AGE: All dogs must be at least 16 weeks of age or older.

SEX: Male dogs 8 months or older must be neutered, and female dogs 1 yr or older must be spayed.

SHOTS: All dogs must have current vaccinations with submitted documented proof of DHLPP and Bordetella vaccinations. Rabies is required for puppies over 4 months of age.

BEHAVIOR: All dogs must be non-aggressive and not food or toy protective. Owners will certify their dogs have not harmed or shown any aggressive or threatening behavior towards any person or any other dog(s). Please remember that this is a pack environment where your dog will be spending their entire day with other dogs, and the safety, health and happiness of all dogs is our main concern.

RESERVATIONS:

Required. Cancellations for boarding with less than 24 hours notice will be charged 50% of the total fee. No-shows for day care will not be refunded.

I hereby certify that my dog(s) is/are in good health and has/have not been ill with any communicable condition in the last two weeks. I further certify that my dog(s) has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog. I have read and understand the following:

- 1) I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending day care or boarding at Chippewa Paws Unleashed, LLC.
- 2) I further understand and agree that in admitting my dog(s) to Chippewa Paws Unleashed, LLC, staff have relied on my representation that my dog(s) is/are in good health and has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
- 3) I further understand that dogs will be together in a large group of all ages, sizes, etc. and agree that Chippewa Paws Unleashed, LLC and their staff will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog's/dogs' attendance and participation at daycare or boarding.
- 4) I further understand and agree that dogs can sometimes sustain wounds including but not limited to cuts and scrapes, as well as bone and ligament injuries at daycare from running and playing with other dogs, and any problems that develop with my dog(s) will be treated as deemed best by staff at Chippewa Paws Unleashed, LLC, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
- 5) All dogs must have current vaccinations, including: Distemper/Parvo, Rabies and Bordetella (Kennel Cough) with proof of vaccinations yearly. Chippewa Paws Unleashed, LLC reserves the right to decline acceptance of a pet if found to have a medical condition or exhibits behavior that suggests care from Chippewa Paws Unleashed, LLC is not in the best interest of the dog.
